The Board of County Commissioners of Curry County, State of New Mexico, has issued the following Addendum #1 to the Request for Proposals for Construction Management Services, Remodel 417 Gidding, RFP No. 2013/14-06.

ADDITIONAL INFORMATION

The County proposed budget amount is in the range of \$3.2 to \$3.7 million. The County projects the pre-construction of 417 Gidding will begin in late Summer to Fall 2014 and the construction phase late 2014 to early 2015 with the construction completion date of Fall/Winter 2015.

The offeror's will have an opportunity to tour the location, 417 Gidding, at the mandatory pre-proposal conference that is set for May 28, 2014 at 3:00 p.m. The offeror's will also be allowed opportunity to measure for available space and take photos during this time.

SPECIAL CONDITIONS

There was an error on page 3 in the numbering and there are no paragraphs for 3, 4 and 5.

PROPOSAL PACKAGE

On page 7, the paragraph in bold, first sentence should be "If additional services are offered that are not part of 1-11 in the Scope of Services, that amount needs to be identified on the fee schedule."

The completed Campaign Contribution Disclosure Form and Addendum #1 shall be completed and submitted in the Proposal Package. These documents will not be counted in the twenty (20) pages in length maximum.

EVALUATION CRITERIA

Paragraph 6 should read "Ability of the offeror to meet time and budget requirements based upon the offeror's response to paragraph 3 of the proposal package portion of this RFP."
