

**CURRY COUNTY
VOLUNTEER FIRE STATION
USE POLICY**

PURPOSE

The purpose of this Policy is to establish the parameters for the use of all Curry County Volunteer fire stations by local non-commercial community groups.

PROCEDURE

Fire Stations may be used by local non-commercial community groups. Requests to use fire stations will be considered on an individual basis with the approval of the District Fire Chief and County Fire Marshal.

Once approved, local non-commercial community groups shall submit a completed Accident Waiver and Release of Liability form (Appendix A) for each participating individual prior to the use of the fire station. Such forms shall be retained by the County Fire Marshal.

Groups using fire stations shall be assessed a fee for the use of the building to maintain compliance with Anti-Donation laws. A per use fee of one (1) dollar has been established by the Curry County Board of Commissioners.

The use or possession of illegal or recreational drugs and/or alcoholic beverages is absolutely prohibited at all times in County Fire Stations and on County Fire Station property.



ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM**

I agree to hold the above-named entities entirely free from all claims, demands, lawsuits, and all other liabilities of any kind, known or unknown, including financial responsibility for any and all injuries or claims of any kind incurred, regardless of whether injuries are caused by negligence.

By signing below, I voluntarily and knowingly, waive, release and forfeit any and all right to file a claim, make a demand, or bring a suit against Curry County, Curry County Volunteer Fire Departments, the Curry County Fire Marshal, and/or their directors, officers, employees, volunteers, representatives and agents, the activity holders, and sponsors for any reason.

I understand that this waiver is based on a calendar year, from January 1 to December 31, and this waiver expires on December 31 of the year it is signed.
