NOTICE IS HEREBY GIVEN that CURRY COUNTY will receive sealed Bids for the RE-ROOFING PROJECT AT PATRICK C. SANDOVAL CURRY COUNTY HEALTH FACILITY, CLOVIS, NEW MEXICO. Bids will be received from Bidders at the Curry County Administration Office, 700 North Main, Suite 10, Clovis, NM no later than:

June 11, 2015 at 2:00 pm MST

and then will be publicly opened and read aloud. Bids received after opening time will be returned unopened.

Bids must be submitted in a sealed envelope that is clearly marked:
“Bid No. 2014-15-06—Do Not Open”

The words “SEALED BID” along with the BIDDER’S NAME AND ADDRESS AS WELL AS THE BID NUMBER AND PROJECT MUST appear clearly on the outside of sealed envelope or package of all bids.

The bid is to be accompanied by an acceptable Bid Bond or Cashier’s Check, in a sum not less than five percent (5%) of the maximum bid, payable to the Owner, with the understanding that if the proposal is accepted, the Bidder will, within ten (10) days thereafter, enter into a contract and give acceptable Surety Company Performance Bond and Payment Bond, in the full amount of the contract for such work.

Bids may not be withdrawn after the bid opening for at least 45 days, or until Notice of Award of Contract or Rejection of Proposal has been received.

In case of failure of the successful bidder to enter into a Contract and give acceptable Performance Bond and Payment Bond, the Bid Bond or Cashier’s Check will be forfeited to the Owner as liquidated damages, otherwise it will be returned to the Bidder within forty-five (45) days from the date of opening of bid.

All Competitive Bids shall be in accordance with plans, specifications and contract documents which were prepared by and may be examined without charge in the office of the Engineer, Jim D. Koontz & Associates, Inc., 3120 North Grimes, Hobbs, New Mexico. For any additional or mailed copies a non-refundable fee of one-hundred dollars (\$100.00) per set will be required.

Curry County reserves the right to reject any or all bids and to waive any formalities and technicalities. Curry County reserves the right to award the contract to multiple bidders.
