This Addendum modifies and is hereby made a part of the contract documents and specifications of the above referenced Curry County Invitation to Bid 2015/16-04. All other requirements and specifications in the original bid documents are to remain the same. Each bidder is required to acknowledge receipt of this addendum by completing the acknowledgement.

The Bid opening date has been changed to April 22, 2016 at 3:00 p.m. in the Conference Room, Curry County Courthouse, 700 N. Main, Clovis, NM 88101.

Included with this addendum and attached is a very detailed Asbestos Inspection report performed by Sun City Analytical, Inc. on structures at 400 and 404 Axtell Street, Clovis, NM that is provided for your information and consideration of the bid requirements.

Bid security in the amount of ten percent (10%) of the amount of the bid shall accompany the bid proposal and must be in the form of a certified or bank cashier's check made payable to Owner, or a bid bond issued by a surety licensed to conduct business in the State of New Mexico and named in the current list of "Surety Companies Acceptable on Federal Bonds" as published in the Federal Register by the Audit Staff Bureau of Accounts, U.S. Treasury Department. The Bid Security of the successful bidder will be retained until he has executed the Agreement, whereupon it will be returned. Bid Security of bidders who are not awarded a contract will be returned within seven (7) days of the bid opening.

Scope of Work:

Delete #7 of the original Invitation to Bid and replace with:
County expect to award contract no later than May 3, 2016 and requires work to be completed no later than May 20, 2016.

Additional Scope of Work:

8. Property at 400 Axtell has a basement that is approximately 650 square feet that requires filling to level with the surrounding grounds.
9. The demolition of the roof on the detached garage building at 400 Axtell will not include any use of power roof saws as recommended in the asbestos survey performed by Sun City Analytical, Inc.

All of the remaining aspects of the original BID are not altered by this addendum.
